



## **Memorandum of Understanding**

Between

**Northwest A&F University, China**

and

**Institute of Field and Vegetable Crops, Serbia**

---

1. Northwest A&F University, 3 Taicheng Rd, Yangling Qu, Xianyang Shi, Shaanxi Sheng, China, 712100 represented by President Professor Wu Pute and Institute of Field and Vegetable Crops, Maksima Gorkog 30, 21000 Novi Sad, Serbia, represented by director Dr. Svetlana Balesevic Tubic (the Institutions) desiring to develop co-operation and collaboration in teaching, training, research and other agreed activities that further the aims and objectives of the Institutions, agree as follows:
  - 1.1. To encourage, and use their best endeavours to effect, visits from one Institution to the other by members of the academic staff for the purpose of participating in teaching, training, research programs and other agreed activities.
  - 1.2. To offer qualified students from one institution admission to undergraduate and graduate degree programs at the other institution.
  - 1.3. To encourage the exchange of scientific materials, publications and information.
  - 1.4. For each activity undertaken in this Memorandum, a working program will be developed and outlined in a written document (specific agreement, annex or similar) detailing the specific form and content of the activity together with the responsibilities of each Institution, as provided in Article 5 hereof. The faculties and other units forming part of the Institutions may participate in this specific arrangements.
2. The Institutions acknowledge that all visits of staff and the admission of students will be subject to compliance with the entry and visa regulations of China and Serbia and the Institutions' requirements in respect of admission and staff appointments.
3. The Institutions acknowledge that in the absence of any specific agreement to the contrary, all expenses of salary, travel, living and allied costs will be determined at the discretion, and be the responsibility, of the visitor's home Institution. Neither Institution shall assume any direct financial liability hereunder.

4. The Institutions agree to review this Memorandum after 5 years from the date hereof. It may be terminated at any time by mutual consent or by 6 months' notice by either Institution.
5. This Memorandum is not intended to create legal or binding obligations on either Institution. Any agreements arising from this collaboration (including intellectual property) will be incorporated into a formal separate agreement or agreements in good faith.
6. This Memorandum has been drawn in six (6) originals, two (2) of them in English, two (2) of them in Chinese and two (2) of them in Serbian, the English text prevailing.
